# **Budget**

- ➤ NENA does not currently offer on-line training. They did previously and it was not well received and therefore cut from the training agenda.
- A reminder that we promised to host a NENA Course in the spring to get the half price course during the conference this past year. This negotiation took place because we had only six people registered at \$125 for a \$4000 course. They were good to us and I feel that we need to keep our word. Good news is that for each course hosted we get a chance to win a free course in a drawing at national. This second class will double our chances to win!
- A standing committee was appointed a couple of years ago to work on the 07 national conference. I have been chairing for the past two years and working closely with NENA national staff. I would humbly request that the board members assigned to talk with Bill Munn about this same issue talk to me as well. I don't want us doing double or conflicting work and think we should be united on our efforts. I have strong ties with NENA national and would like to continue working with them on this project. Some of our original ideas have been nixed due to three changes in NENA staff person assigned and a change in the hotel facilities. However, I would like to keep some of the continuity that we have started for this process.
